Extended Health, Drug Coverage, Dental and Vision* — SunLife

Coverage is available for Team Members, spouse/domestic partner and eligible dependent children if elected by Team Member.

Short-Term Disability (STD)* — SunLife

STD is a company-paid benefit that provides a portion of the Team Member's income if a Team Member becomes unable to work due to a non-work related illness or accidental injury for up to 17 weeks.

Long Term Disability (LTD)* — SunLife

LTD is a mandatory Team Member paid benefit for all Team Members eligible for the Extended Health/Vision and Dental benefits that provides a portion of income for as long as an individual is unable to work due to a non-work related illness or injury up to age 65. You will be enrolled in a 40% replacement benefit unless you "buy up" to a 60% benefit.

Basic Life Insurance and Basic AD&D* — SunLife

Michaels provides Basic Life Insurance and Accidental Death and Dismemberment (AD&D) coverage, of 1 times annual earnings up to \$150,000, at no cost for Team Members.

Optional Critical Illness* — SunLife

Team Members can choose to purchase Optional Critical Illness for themselves and/or their eligible spouse/domestic partner and dependent children.

Optional Life Insurance and AD&D* — SunLife

Team Members can choose to purchase Optional Life Insurance and AD&D for themselves and/or their eligible spouse/domestic partner.

DPSP — Manulife

Team Members are eligible to participate in the DPSP after completing 500 hours of service in a 6-month period or 1,000 hours of service in a 12-month period. For every \$1 you save in your GRRSP account, Michaels will add \$.50 cents, limited to 3% to your DPSP account.

Tuition Assistance

After 500 hours of continuous service, Team Members may be eligible for \$2,000 per year in Tuition Assistance.

Adoption Assistance

After 1 year of continuous service, Team Members may be eligible for \$5,000 in Adoption Assistance.
